TRASH REMINDERS

According to the Vista La Jolla Townhomes Association Policy Manual, Page 5, Section C.,

Refuse Control, #2: "Residents shall not put trash containers curbside before 4:00pm the day before scheduled pick-up. Residents



shall collect their empty trash containers the same day that the City collects and removes the paper bags curbside for trash collection, as the City will not pick up or remove them." Please be sure that you abide by the trash rules or you could be in violation and receive a notice. Please place containers curbside before 4:00pm the day before scheduled pick-up. Residents shall collect their empty trash containers the same day the City collects and removes them.
