## <u>Parkíng Remínders</u>



With the upcoming holidays, many homeowners will have visitors. Please review the following parking rules and \*remember to inform all your holiday guests of the parking rules.\*

- Garages must be utilized for parking two vehicles.
- Parking boats, trailers, and motor homes are prohibited on all streets.
- Guests must park in designated guest spaces and at raised curbs.
- Always allow a twenty-foot driving lane between parked vehicles when parking.
- Blocking any driveway, garage, or sidewalk is in direct violation of the City ordinance.
- Red curbs are Fire Lanes, blocking them can result in towing and fines from the City.
- Parking facing the wrong way is against the law and prohibited.

\*Violating any of the above parking rules may result in a violation or hearing notice, and your car can be towed. If you are called to a hearing, you may be fined.\*

# <u>Holíday Líghts</u>

With the end of the holiday season approaching, we know you might have questions regarding when the holiday lighting has to be taken down. Holiday

lights must be removed bv the end of the following date, January 15<sup>th</sup>. If these rules are not followed, you receive may а violation letter or called be to а hearing where you may be fined.



<u>Vehícle Safety</u>



Around the holiday season, do your part to keep your vehicles and the community safe from prowlers!

Always take keys and fully lock your entire vehicle.

If valuable items such as holiday gifts must be kept in your vehicle, be sure they are out of sight. Hide the garage door opener, as it is a key to your home.

Keep your vehicles in the garage. Not only is it required by the Vista La Jolla Governing Documents, it is the best way to protect your vehicles.

•Use an engraver to etch a CA Driver's License Number on stereos and other valuable items and vehicle parts.

Be alert to suspicious activity like someone loitering in the neighborhood or looking in vehicle windows. Be alert to sounds. Most vehicle burglars steal things by breaking a car window. While it is happening, report suspicious activity to the Police.
